### Did you know...

♣ A Standing chairperson has voting privileges when attending Board Meetings. If a Chairperson(s) *is jointly held only* **one vote shall be accorded to each position.**

♣ Each Standing chairperson will attend **at least two board meetings** per year.

♣ Associate Membership - An Associate Member will be defined as one who financially supports Club. An Associate is welcome at all Club Meetings, projects and functions. Upon submission and acceptance of a written request, Associate status will be to:

1. An individual who has been an Active Member in good standing for two (2) years.
2. The Associate will pay a yearly non-refundable fee of \$20.00
3. An Associate Member may not vote, hold office or receive financial disbursements.
4. An Associate who wishes to resume Active status during the Club year will pay prorated Club dues. All voting privileges and membership requirements would then be reinstated.
